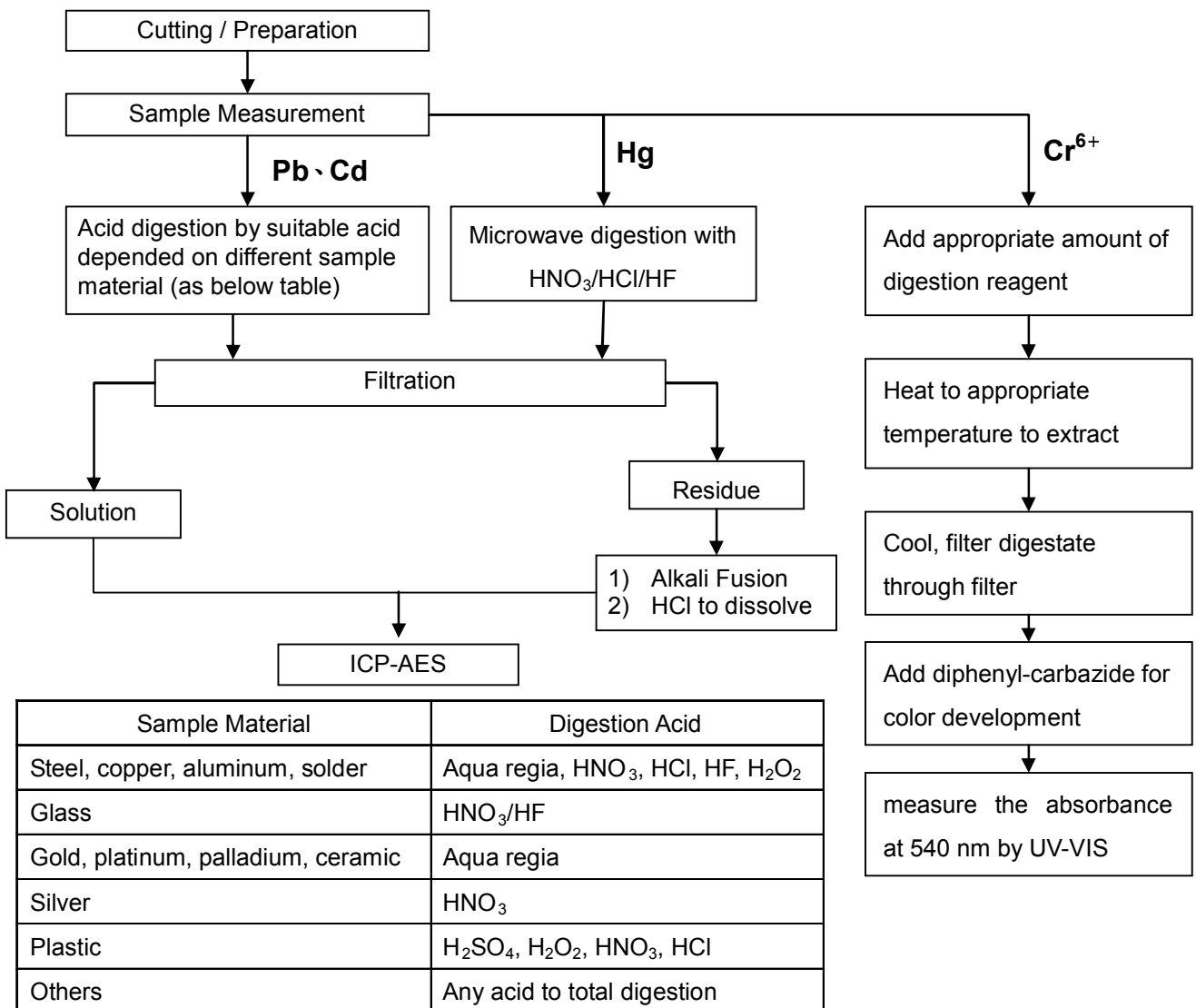

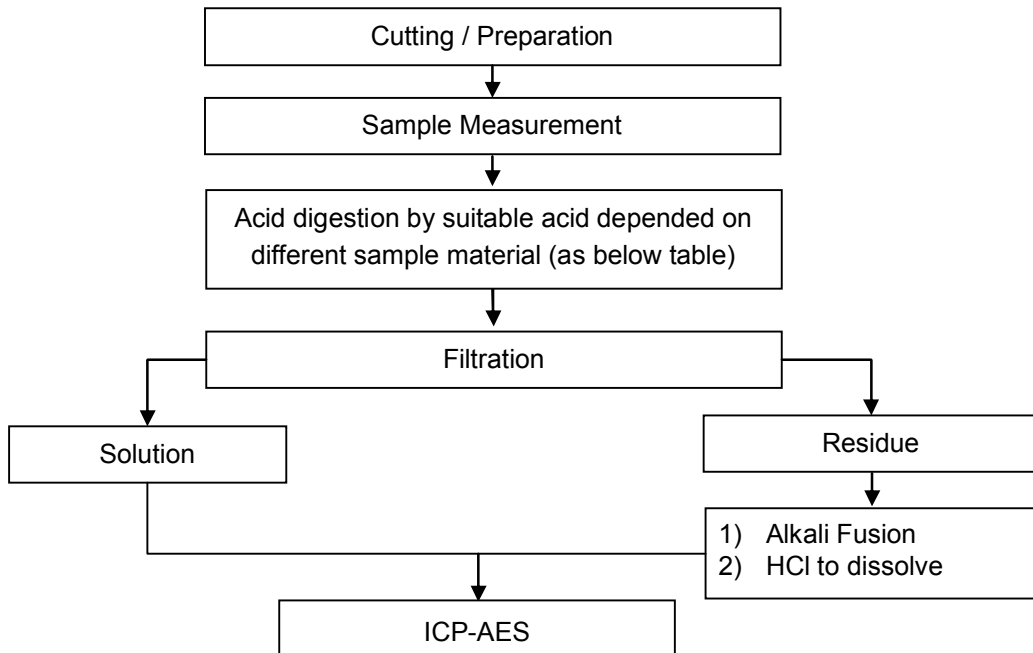

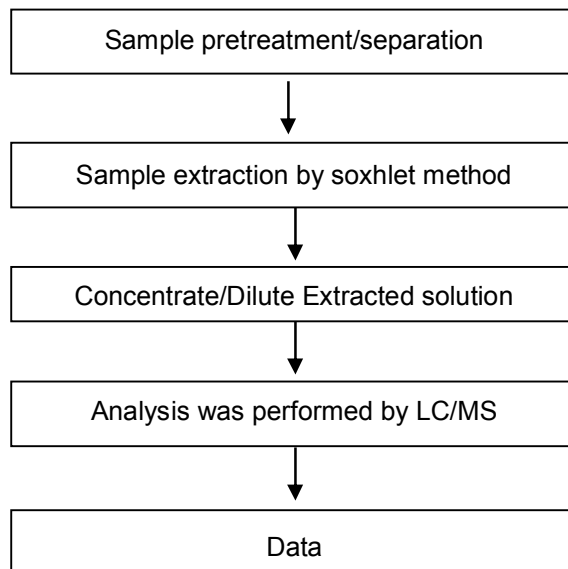

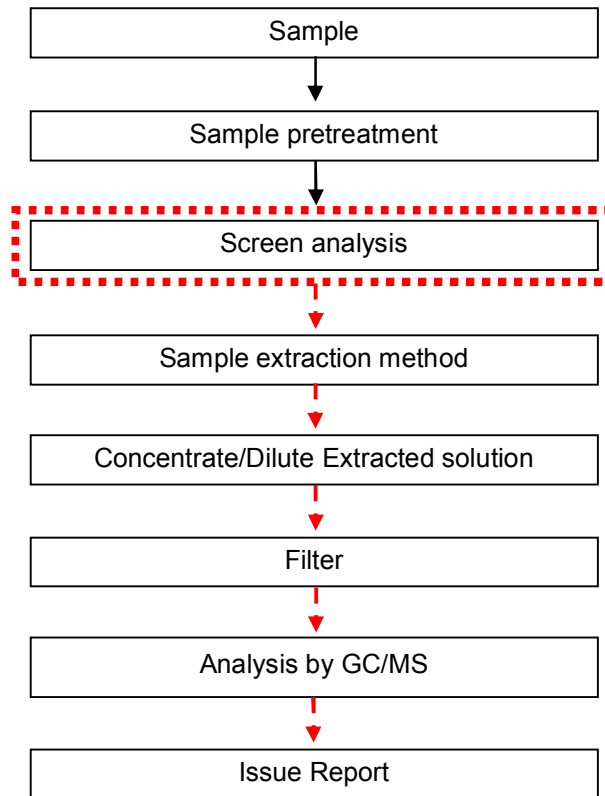


Analytical flow chart

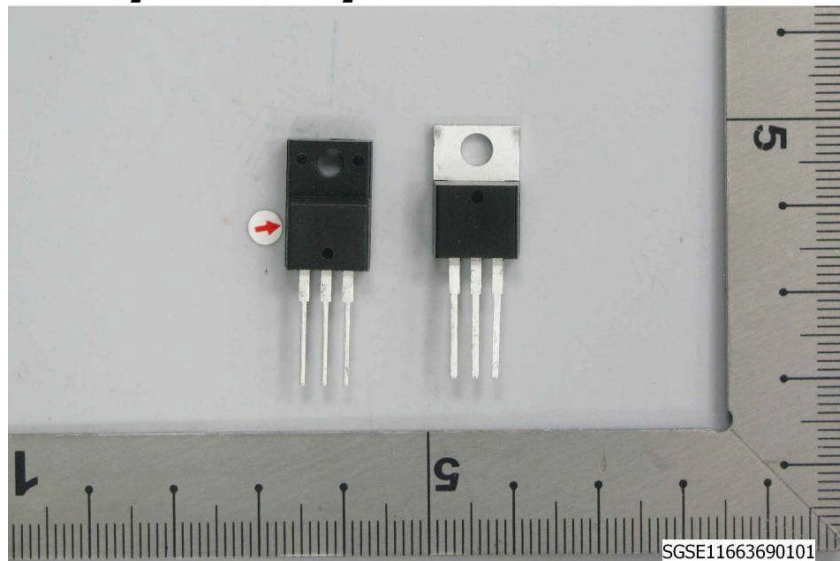

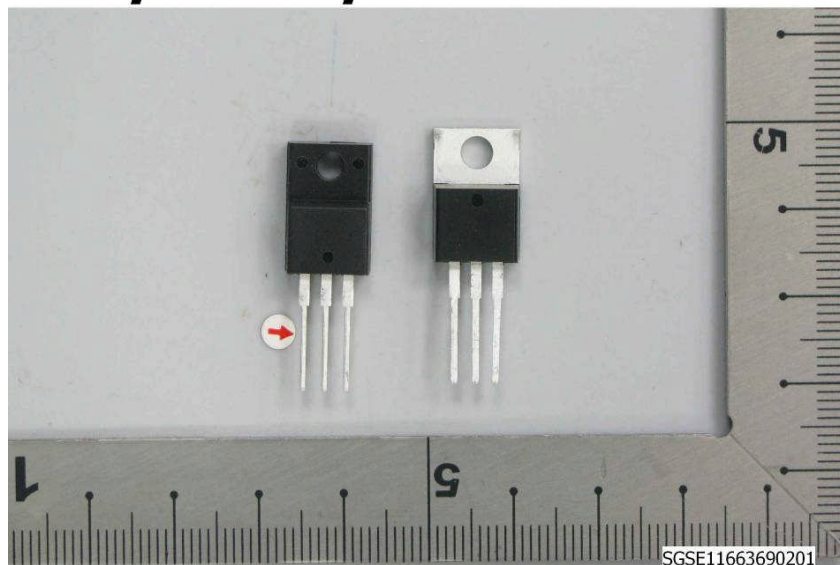
